HOME INSPECTION: A home inspection assists in identifying existing problems, and allows you the opportunity to review and approve the home's condition prior to purchase. It should be done during the inspection period outlined in the purchase contract. Professional help is strongly advised, as Ken Meade Realty Associates are not qualified or trained to conduct home inspections and cannot make any representations or warranties as to the condition of the property. Items that a home inspection company may look at include:

Structural Electrical System Plumbing Built-in Appliances Roof Fences & Gates Ventilation Foundations Hot Water Heater Safety Hazards Siding/Stucco Patio (s) / Decks Air Conditioning System (s) Heating Systems Attic Doors/Windows

Be sure to verify what items are included in your home inspection

Presence of mold, wood infestation, heat exchangers, lead based paint, radon, geological, environmental or pollution inspections are normally not included. You may also wish to obtain inspections in these specialized areas.

HOME WARRANTY: A home warranty helps shield you from unexpected repair expenses after you have purchased your home. The items covered in the warranty must be in working order at the time the warranty goes into effect. Home warranties do not cover pre-existing conditions.
